OVCBCHW TRAIL BOSS REPORT

February is a pretty quiet month for Trail Boss. Our first outdoor activity is on March 10th at the Tonasket US Forest Service Conference room at 13:00.



We have the Rendezvous in Ellensburg on March 16-18th. We hope to see many of you there this year. Our first trail clearing opportunity is on March 31st in the Sinlahekin. Details of this will be in the next report.

I'd like to again take space in this newsletter to issue a challenge to each and every member to partake in at least two work party events in 2012. Not everyone needs to run a chainsaw or work as a swamper. On the trails we clear with horses, wranglers are always in short supply. If one or two people volunteer to take care of the horses for the cutters and swampers, we can clear more miles of trail in less time. I would also like to have potlucks and BBQ's after some of the work parties. We need people to organize these events. This is one way to contribute without ever firing up a saw or dragging a single limb.

At my place the weather has warmed up enough during the day to consolidate the snow so the nighttime temperatures can turn it into large patches of ice. Keep an eye on this because when the sun first comes out in the morning the horses tend to want to run around and play with one another. A little sand sprinkled in the worst parts may help you avoid an accident. There is nothing worse than a lame horse going into the riding season.

Only An Opinion

This time of year the question always comes up should I blanket my horse? Healthy horses remain free of problems if they are well acclimatized to the existing weather and not in a false environment. Shelter from the wind and rain/snow with clean fresh air and access to fresh unfrozen water is important. A horse will not get enough water eating snow as his only source of water. The average horse needs 8-10 gallons of water daily. A tank with a 45+/- degree water is helpful, imagine drinking ice water in 10 degree weather and trying to stay warm. Adequate feed (digestion of roughage is what produces body heat) fed on a regular basis. A 1000 lb. horse needs 16-20 lbs of good hay per day. Hay more than grain will produce calories needed to keep him strong. If your horse is very thin then I might blanket him to help protect the calories needed to maintain body heat. Realize he is now in a false environment and could be more susceptible to problems related to skin infections or chilling or overheating as the blanket is on, or should come off. A healthy well cared for horse with shelter will do fine without a blanket.

OVCHBCHW LEGISLATIVE REPORT

OVCHBCHW LEGISLATIVE REPORT BY: DAVE SUNDE

Legislative Day has come and gone for the year. I was not able to attend this year, but many of our members from the West side did manage to brave the torrential rain, mud, and power r outrages to attend. Many of the legislators heard again our concerns.

The bill cutoff dates run from February 2nd to the 14th. Bills that we re concerned with are already either in committee or on the floor. The biggest things we are watching are the following:

Discover Pass” Senator Ranker’s bill (SSB5977) making the Discover Pass transferable between two vehicles passed the senate-44-0

NOVA: More on this is now coming to light, and NOVA is again specifically at risk of a sweep to State Parks. Due to the education lawsuit, the legislature is under pressure to move around every dollar they can find. Anything not nailed down is at risk. I is hard to say if the legislators were being specific about the NOVA fund, but they are right that the potential is certainly there. The House is trying to come up with a projected remaining shortfall in the State Parks budget. The gas tax funds (NOVA/boaters/snowmobile) are at risk of another sweep as well as possibly all Discover Pass funds that to DNR and WDFW. There is a lawsuit pending before the Supreme Court so this issue is still in play.

Other committee chairs for the next couple of years will be presented for Board confirmation and approval at the Board meeting in March. The biggest bit of news; though, was the Board's approval of the Executive Director Committee's recommendation that BCHW move forward to hire an Executive Director for the organization. Stay tuned on this deal as position description is developed; a search committee put together; the position advertised within the state and nationally; and an individual is interviewed, selected and hired. All of that is supposed to happen before the end of the year. In other activity at the State level, BCHW has opened a Face book page and already has several hundred friends. I'm not too skookum on the social media and how it works, but I'm assured that it is an excellent way to stay in touch with what is going on and to let others know in a short order what is happening between publication of issues of the Trailhead News. If that is the case, it cannot be a bad deal! Check it out-I plan to. Additionally, the Board approved the recommendation of the Ways and Means Committee to do the calendar raffle again for 2013.
