
Nora's job is open immediately and Tryg will do the newsletter only through December . So if anyone wants to step up please do!!!

The following reports will appear in the newsletter and on the website as Dave Sunde was not present: Directors, Trail Boss, Legislative, and website.


Volunteer Hours: make sure you turn in your volunteer hours monthly. Peggy Swanberg told us they need to be in by the end of the month.

### **NEW BUSINESS**

Whistler Canyon Property Sales: Dave Swanberg went to a meeting with the county commissioners for public input on the sales of Surplus Property near the Whistler Canyon Trail Head. The county wants to keep 3.7 acres at the trailhead and make easements through the proposed land for sale to the Frog Pond and through the scabland to the upper trail. There will be a meeting on Mon Sept 23 at 1:30 PM to set prices for the parcels which will be auctioned in December. The BLM has written a letter stating that they are still interested in purchasing the land but a new EIS Survey is necessary. The BCHOVC has \$34,000 which it could apply to the land purchase if other monies are available. Marc Morris is talking to Kinross to see if they will donate additional money.

Directors Meeting: Dave Swanberg reminded us that the 2014 dues will be going up \$5.00 and that new forms should be here in October. The directors are looking for nominations for people for the awards ceremony. Dave also stated that BCHW has 15086 members, which are 2.2% down from last year.

BCHW Store: Dave Swanberg will be attending the meeting and if anyone wants anything from the store he can bring it back.


## **Director's Report**

Dave Swanburg, Alternate Director

I attended the 3rd Quarter BCHW Board meeting. Hereafter is my report: Reports:

- A. Treasurer- 2014 budget was reviewed and approved by the board.
- B. Membership- 2013 memberships are at 1586, 2.2% less than 2012, with families at 42.4% and single members at 50.4%. 2014 family memberships will cost \$54.00 and single membership will cost \$41.00, plus \$10...00 for chapter membership.
- C. Nominations- The nominations for 2014 and 2015 are: President-Trygve Culp; VP-Jim Anderson; BCHA Director I- Darrell Wallace; Alt. Director-Ken Carmichael.
- D. Ways and Means- A new BCHW Fundraiser Program was proposed and approved by the board with amendments. This program covers all fundraisers that are raising money for BCHW only, does not address or include the chapter fundraisers. Examples are the Rendezvous, Ken Wilcox Ride, the Wine Ride and any future fundraisers.
  - a. Wilcox Ride made \$750 gross and the Store made \$550
  - b. Rendezvous-made \$15,496 net
  - c. New Wine Ride is estimated to make approx. \$10,000 gross.
- E. Education- There are now 130 members who are trained to certify chapter members. On 5/08/14, there will be a train the chapter trainer at Cougar Flats next year. LNT training will take place on April 5<sup>th</sup> and 6<sup>th</sup> at Randle





F. Grants- We will be receiving an RCO grant \$150,000.on approx. Oct 1st. There is approx. \$39,000 available for Chapters to apply for main of trails and tools. Chapters need to apply for these funds by Oct.15<sup>th</sup>.

> Next RCO 2 year grant submittal is scheduled for 6/1/2014. If Chapters want to apply for this grant they must have a member(s) attend a grant work shop at the 2014 Rendezvous.

- G. Legislative- Gjurasic and Kohl submitted a contract proposal to represent BCHW in the legislative procedures in Olympia in 2014. It was discussed and approved by the board.
- H. Awards- Program was discussed and a committee will be established to review and recommend the # of Lifetime Achievement Awards that should be handed out each year.

#### **New Business:**

- 1. Timing of tax reporting- Teri asked that the Chapters close their yearend books by mid December an order for her to complete her work by end of Feb.
- 2. Teri will be holding a Treasurer training meeting in Jan of next year and asked all Directors o impress on their treasurers that they must attend the meeting.
- 3. Business Plan- A proposal was presented to prepare a BCHW Business Plan. It was discussed and approved to proceed with a preliminary draft.

### Good of the Order:

Whistler Canyon- The proposed auction sale of the WC property was discussed and a motion was made and approved by the board to use the money collected by OVC for a down payment to purchase the WC property to be used by collaborative group to purchase the scab land of WC trail system and sell to a government entity.



## **Trail Boss Report**

September was a wet one. The Maple Mountain to Sweat Creek ride through was postponed and probably cancelled for this year. It seems that no one wants to ride 4 hours in heavy rain. I can't say as I blame them.


On the 17<sup>th</sup> a few of us attended the Okanogan County Commissioner's meeting in Okanogan. The business before the group was the surplus of the Whistler canyon property that the County purchased several years ago for the trailhead. The land has been divided into 3 parcels. One is the 32.5 acre parcel containing the agricultural ground, one is a 3.7 acre parcel for the trailhead, and one is a large 63 acre parcel containing the scab land. The county says that the scab land will be sold with an easement for the PNWNST as well as the Frog Pond trail. The Agricultural parcel will be sold with an easement for the trailhead driveway. This is an ongoing issue with the chapter and several other user groups involved. I believe there will be more information posted elsewhere in this newsletter. We will also have a discussion at the next membership meeting on the 16<sup>th</sup>.

On the 25<sup>th</sup> a few of us had a work party out of the Wilcox Trailhead. We packed in three 8 foot posts with signs and placed them at the more confusing spots on the Wild Horse Spring trail. We also identified locations where additional signage is needed and will be going up again on October 8<sup>th</sup> to complete this work. Anyone who can make this is welcome to attend. I think Gail will again have some sort of hot meal for us when we get back at the trailhead.

The annual Fall Color Ride has been replaced this year by a ride at Soap Lake on the 5<sup>th</sup> of October. Cathy will be emailing directions prior to the event.

Hunting season is upon us so be sure both horse and rider are wearing "hunter orange" when out riding. Now is a good time to be thinking of taking off the horseshoes and oiling up the tack for winter storage. Remember that mice are very fond of chewing on salt infused leather so cats, traps or some other deterrent will help save your equipment. This is also a good time to make sure those tank heaters piled on a back shelf still work and don't have any frayed cords or hot spots in the cal rod. Some heaters don't have grounded plugs so be sure and check any exposed metal with a neon voltage tester. Above all, make sure the heaters are plugged into a GFCI outlet. An energized heater can create current flow through either the brain or heart, either of which can prove fatal.

The end of year reporting for volunteer hours is due on the 30<sup>th</sup> of September. If you have not turned in your hours up to now, please make every effort to get them in. Nora is no longer our coordinator, so please send them to Cathy. If you have any questions on how to fill out the spreadsheet you can also feel free to call me and I can help you. We tried to capture hours from people that don't normally show up for work parties by having Gail available at work parties to manually record the hours, but that probably did not capture all the hours. We need to stay on top of this to make sure that every hour is properly reported.
